Service Change Project Update

Summary of Change: Effective July 1, 2025 NDIT Records Management will no longer create or design state forms as a service.

NDIT Records Management will continue to:

- Oversee program and provide education and training materials
- Provide support for enterprise tools (available to answer questions/troubleshoot)
- Review forms to ensure they meet standards
- Assign State Form Number (SFN) and assist in inventory maintenance

Agencies will be responsible for:

- Design, maintenance, and management your own forms, submission for review and SFN assignment
- Working with NDIT app developers for forms that require enhanced features (Jotform, Dynamics, ServiceNow)

Service Change Project Update

Action Required:

- Prepare: Plan and budget for the transition of form creation and design tasks to an in-house individual or team.
- Identify Training Needs: Assess your training needs and take advantage of the available resources and training opportunities provided by NDIT Records Management.
- Licensing: Ensure your team has access to the necessary software, such as Adobe Designer and Adobe Pro and/or JotForm. These tools are available for low or no additional cost. Contact NDIT (Chuck Picard) if additional licenses are needed.
- Legacy Forms: If you still have forms in legacy systems such as Liquid Office, they will need to be deleted or converted to another product (such as Adobe) prior to July 1. We will not be able to provide the design tools to maintain these forms as they are no longer supported. Contact Records Management as soon as possible if you have legacy forms.

Self-Service Data Collection Tools

Adobe Designer (AEM)

- Used for designing fillable/printable PDF forms
- Enterprise solution: Most state forms are currently PDF forms
- Designer is more robust than Acrobat Pro for forms design
- Can be integrated with Adobe Sign
- Designer licenses are available at no additional cost

Self-Service Data Collection Tools



- Used for web-based data collection
- Can stand alone or be integrated with other systems or websites
- PDF forms can be directly replaced
- Options to protect regulated data
- Licenses are available at a cost of \$86/mo per named user (requires an annual commitment)
 - Grants access to design, maintain, and publish web forms
 - Grants access to submitted data
 - Grants access to vendor support

Self-Service Data Collection Tools



- Used to create web-based surveys, polls, and basic data entry forms
- Not considered an enterprise solution/not suitable for official state forms (should be internal use only)
 - Access Management Concerns
 - Limited Customization Options
 - Not capable of meeting State Forms program design standards.
 - Response Limits and Restrictions
- No cost/provided with M365 licensing



Data Intake and Collection Matrix




State Forms Central Repository
